



Privacy Statement

Maasdael Corporate Finance B.V. ("Maasdael") values the protection of your personal data. Therefore, Maasdael handles your personal data in accordance with the applicable privacy legislation. Through this Privacy Statement we inform you about the manner in which Maasdael processes your personal data.

Maasdael is located in Rotterdam and is registered in the Trade Register of the Chamber of Commerce under number 24437490.

To whom does this Privacy Statement apply?

This Privacy Statement applies to everyone for whom Maasdael processes personal data.

An overview of the most important categories is listed below:

- Visitors to our website;
- Maasdael's clients (and their employees);
- Maasdael's prospects;
- People involved in a transaction in which Maasdael acts as corporate finance advisor;
- Third parties that communicate with Maasdael.

What personal data does Maasdael process?

Maasdael processes personal data that you have provided to us, personal data generated during your visit to our website and personal data we have derived from other sources.

Provided to Maasdael by you:

- Contact details and other personal data that are necessary for handling your case;
- Personal data you provide to Maasdael in the context of events, seminars and meetings;
- Data concerning your visit to our website;
- Data concerning the device you used to visit our website, for example your IP address.

Personal data received from other sources:

- Personal data received from public online sources such as company websites and social media platforms such as LinkedIn;
- Personal data obtained from the Trade Register of the Chamber of Commerce;
- Other personal data relating to you that we obtained in handling cases via (inter alia) clients and market studies.

Why does Maasdael process your personal data?

Maasdael uses your personal data for several purposes:

- To provide corporate finance services performed by our consultants for our clients;
- To comply with our statutory obligations;
- To contact and communicate with you;
- To secure, use and improve our website. For a more comprehensive explanation of this, see the section on 'cookies'.
- To improve the quality of our services.

The protection of your data

Maasdael has taken appropriate technical and organizational measures to protect your personal data against loss or against any form of unlawful processing. People who have access to your data or files on Maasdael's behalf have a duty of confidentiality. Sharing data with third parties

The transfer of your personal data to the abovementioned third parties will only take place for the purposes mentioned in this Privacy Statement.

Third parties to whom we provide your personal data may themselves be responsible for complying with privacy legislation. Maasdael is neither responsible nor liable for the processing of your personal data by these third parties. To the extent that a third party processes your personal data as a Processor of Maasdael, Maasdael concludes a processing agreement with such third party which meets the requirements set out in the legislation.

Retention period

Maasdael will not retain your personal data any longer than is necessary for achieving the purposes in this Privacy Statement or for complying with statutory retention periods.

Your rights
